 - 5. In accordance with the Tobacco Plains Indian Band Custom Election Law, 2019, I organized and facilitated a Nomination Meeting;
 - 6. A copy of the Notice of Nomination Results and All Candidates Forum is attached as Exhibit "C" to this Declaration;*
 - 7. A copy of the Notice of Election is attached as Exhibit "D" to this Declaration;*
 - 8. In accordance with the Tobacco Plains Indian Band Custom Election Law, 2019, I publicly posted the Notice of Election and Notice of Nomination Results and All Candidates Forum, and I delivered copies of the Notice of Nomination Results and All Candidates Forum and Notice of Election to each elector;
 - 9. A copy of the Mail-in Ballot Package is attached as Exhibit "E" to this Declaration;*
 - 10. In accordance with the Tobacco Plains Indian Band Custom Election Law, 2019, I delivered a Mail-in Ballot Package to each elector who is not ordinarily resident on Reserve and to each elector from whom I received a request for a Mail-in Ballot Package;
 - 11. I was responsible for overseeing all voting and for counting all ballots cast in Tobacco Plains Indian Band Council Election;
 - 12. The number of electors was **191** and their names are entered on the electors' list, which is attached as Exhibit "F" to this Declaration;*

- (e) **0** ballots were spoiled;
- (f) **0** ballots were rejected;
- (g) **0** ballots were cancelled;

- (i) **71** ballots were marked in favour of **Alicia Phillips**, who I declared elected for the position of Councillor;
- (j) <u>61</u> ballots were marked in favour of <u>Beckie Cayenne-Ban Quan</u>, who I declared elected for the position of Councillor;
